It is imperative that you submit your application for the Institute as soon as possible so that a space can be reserved for you since NCBAALeadership Development Institute accepts only 20-25 participants.

Selection of the scholarship recipient will be based on the criteria listed below.

Scholarship Criteria:

Please provide written documentation for the following:

- at least 5-10 years of progressive experience in the field of higher education with an emphasis on the community college
- an understanding and appreciation for the community college mission and its students
- progressive advancement toward leadership positions within the community college system
- verification, from supervisor, indicating the extent to which the institution will support you financially.
